Proposal for Discontinuation / Consolidation Daily**

SUBSCRIBER NOTE: S&P Global proposes changes to Enerdata daily natural gas indices

---

Following a period of market feedback and review of existing Canadian Enerdata Ltd. natural gas pricing, S&P Global Platts has decided to proceed with the following discontinuations, consolidations and additions to the daily Enerdata indices from June 1, 2020 trade date.

Platts will make the following changes:

- Discontinue all CGPR Enerdata daily indices. These CGPR indices are currently comprised of ICE NGX trade data and Enerdata price reporter non-ICE NGX trades. These would be replaced by ICE NGX indices or Platts indices, where applicable. This change does not impact existing NGX contracts, which will continue to be published.
- Discontinue and consolidate various pricing tables on Enerdata.com
- Add daily NGX locations that are currently not published in existing Enerdata publications for complete record of NGX contracts

**Discontinuations on Enerdata.com:**

The following daily tables currently published on Enerdata.com will be discontinued, and consolidated into a single daily pricing table alongside a rolling month to date value for each location:
