Re: Important Legal Notice Regarding Exclusive License

Dear Subscribers and Recipients:

This letter is to inform the subscribers of Canadian Gas Price Reporter (CGPR) Daily, Weekly and Monthly and recipients of CGPR data files from Canadian Enerdata Ltd. ("Enerdata") (the "CGPR Publications and Data") that in March 2007, IntercontinentalExchange, Inc. ("ICE") acquired the exclusive right to use several proprietary indices of Natural Gas Exchange Inc. ("NGX"), which are listed in Exhibit A to this letter (the "Licensed NGX Indices"), for the purpose of trading and clearing derivative products. Currently, no other exchange, trading platform or clearinghouse that trades or clears derivative products has a license for such purposes. Canadian Enerdata Ltd. has the right, by Agreement with NGX, to publish the NGX Indices in the CGPR Publications and Data.

We are writing to request that all subscribers accessing Licensed NGX Indices through the CGPR Publications and Data be aware of the restrictions that exist related to any transmission or redistribution of the NGX Indices. Because the NGX Indices are proprietary indices only available through Enerdata by a subscription, the terms and conditions of use pursuant to which you are provided access to the CGPR Publications and Data containing the NGX Indices prohibits you from providing, redistributing, broadcasting, disseminating, or sharing any data relating to the Licensed NGX Indices with any third party, including without limitation any exchange, trading platform or clearinghouse. Any such distribution of the Licensed NGX Indices would be viewed as a violation of the terms and conditions of use by which you access the CGPR Publications and Data.

Please ensure that you provide a copy of this notice to all persons within your organization who have access to the CGPR Publications and Data.
